Discussion

Len reviewed the report as included in the agenda.

Questions were raised about how driveways are paid for and complication with different snow amounts per year. It was clarified that driveway clearing is optional and 100% paid for by each participating homeowner. Snow clearing costs are estimated at the beginning of each year with the understanding an unusually heavy snowfall year may require additional funding.

5. Review the work of the Executive over the past year (Joanne)

Discussion

Joanne reviewed her report highlighting the new north fence with emergency egress, and that a new sign is in development to be added to that fence.

A question was posed asking if the new sign should include "no motorized vehicles." Responses:

- The purpose of the sign should be to adequately protect us from liability.
- FOCA suggested best wording is "No trespassing." Second best is "Use at your own risk." We are choosing "Use at your own risk."
- Have noticed more ATVs and motor bikes recently so support "no motorized vehicles."
- Purpose of sign is liability protection, not enforcement.

Motion put forward for sign at north end that says "private road, use at own risk, no motorized vehicles."

Evelyn and various members gave background to original sign installation and then noted how sign came to be moved without LRSA permission.

LRSA sent letter to council expressing disappointment in the municipality's actions without talking to us first.

No response to date.

Several questions were asked as to the motivation of various parties. More questions than answers.

It was suggested we decided to leave the sign where it is and monitor for the next year. There was also some interest in having the municipality move the sign back to its original position.

Discussion

- A new clause requiring compliance with Drainage Plan has been added.
- A new construction reporting form has also been added as a means of keeping member's informed regarding work on private property that could potentially impact drainage or the road itself.

Discussion

- A question was asked about whether we are putting enough in reserve for the future. The answer is that it will not pay 100% of costs but the intent is that the amount we collect will significantly offset the amount of funding required during the year of the project's construction. This is an attempt to balance the burden of a one-time

payment by members for a capital project, with a reasonable annual contribution to a future capital reserve. This also recognizes that people who are contributing to future capital now may no longer live on the road by the time the project is constructed and it would be unfair for them to pay 100% of costs when the benefit would go to a future resident.
